



SINGA DESIGN COMPETITION 2020

TERMS & CONDITIONS

Entry Requirements

1. The competition will be open between the 4 January and 29 February 2020 (both dates inclusive). All drawings must be submitted to MuzArt Singapore HQ by 4 March 2020, before 9pm.
2. This competition is open to all children ("Participants") for free. Children must be at 3 to 6 years old (CAT A) or 7 to 18 years old (CAT B), according to their birth year.
3. MuzArt reserves the right at any time to require proof of identity and/or eligibility. If the Participant is required to provide such evidence and fails to do so, MuzArt may at its sole discretion, disqualify the Participant from the competition.
4. All Participants intending to participate in the competition must have the consent of their parent or guardian to do so.
5. Only one entry can be made by each child. All competition entries must be the original work of the Participant. Each Participant cannot be assisted by any third parties. Any such entries will be disqualified. Late or incomplete entries will also be disqualified.
6. Only DRY MEDIUM (oil pastels, colour pencils, markers, pens, pencils etc) is allowed on the drawing.
7. Criteria for selection of the winners are based on creativity, originality and overall design.

Prizes

8. All Participants will receive a Certificate of Participation.
9. The winner from each category will get to paint one Singa Figurine as per the design submitted. The painted figurines will be displayed and up for public adoption to help raise funds for charity. Besides that, they will also walk away with MuzArt Complementary Clay / Craft Class and Wild Wild Wet entrance tickets for 2 adults and 2 children.
10. All prizes are non-negotiable, non-transferable and non-refundable. No cash or credit alternatives will be given in exchange for the whole or any part of the prizes. MuzArt reserves the right to substitute the prize with a prize or equivalent value in the event of circumstances outside of its control.
11. The competition winners will be selected by MuzArt. MuzArt's decision is final and binding. No correspondence on any matter concerning the decision to award to the competition winners will be entertained.
12. MuzArt reserves the absolute right to select an alternative winner and award the prize to another Participant in the event that MuzArt has reasonable grounds for believing that that Participant has acted in a way which is inconsistent with these terms and conditions or has acted in a way which MuzArt considers to be inappropriate, unlawful, or offensive.

MuzArt will use each Participant's personal details for the purposes of administering this competition and to contact Participants who are shortlisted and/or winners. MuzArt will also share this information with third parties within the MuzArt group of companies as part of the judging process. By entering this competition and providing this information to us, each Participant and their parent/guardian consents to such personal information and drawings being used in this way.

Your Personal Information and Intellectual Property Rights

Information collected from Participants and/or their parent/guardian will only be disclosed to third parties, including data entry service providers, professional advisers, consultants or auditors, storage and warehousing facility providers and third-party service providers who provide operational, including marketing and publicity services, in connection with the purposes expressed herein. By entering this competition, you consent to us disclosing your personal information in this way notwithstanding that such third parties may be located outside Singapore.
